2. Detailed information and mandatory information

2.1 Data privacy

4.2 Server-log-files

The provider of this website collects and saves automatically information in so-called server-log-files, which are transmitted automatically by your browser. These contain:

The data that is transmitted by e-mail stays with us until you demand deletion, revoke the saving or the purpose for the saving is omitted (e.g. after answering your request).
